- I/we, as event coordinator have read, understand, and agree to the following policies of Hidden Haven Golf Club:
 - All food served and consumed on the premises must be prepared by Hidden Haven Golf Club (except the wedding cake). The wedding cake is the responsibility of the wedding party.
 - Leftover or un-served food may never leave the premises.
 - Absolutely NO carry-in beverages are allowed. All alcohol consumed on the premises must be purchased from Hidden Haven Golf Club. This includes the parking lot.
 - An accurate dinner count must be received ten days in advance of the reservation. Billing will reflect this count.
 - Entertainment must be hired by the wedding coordinator or the event coordinator.
 - Event coordinator is responsible for decorating the reserved room. Décor must be approved by Hidden Haven Golf Club Management, and some prohibited decorations include confetti, glitter, or any similar item.
 - Any persons under 21 or persons without valid ID will not be served alcohol. This includes the wedding party. All children must remain in the banquet room, and minors are not allowed in the general bar area after 9pm.
 - By signing this agreement, all parties waive any and all claims against Hidden Haven Golf Club. We shall assume NO responsibility for lost or stolen property.
 - We accept cash, check, and most major credit cards. A 3% premium will be added to all bills paid by credit card. Final balance is due upon conclusion of reception or event.
